



2025 Street Rehabilitation Project

Project Update
April 18th, 2025

Construction Schedule Update:

The City's street contractor is currently anticipated to begin concrete pavement rehabilitation in August. In preparation for this work, coordinated public and private utility improvements will be taking place over the coming months. Additional detail regarding construction scheduling will be provided to project residents as it becomes available.

Please note that all construction scheduling is tentative, weather-dependent and subject to change.

Traffic Calming Improvements:

On Monday, April 14th, the City of Fridley Council ordered traffic calming improvements along East Danube Road in conjunction with the 2025 Street Rehabilitation Project. The project will include the construction of two (2) reinforced concrete speed humps with associated pavement markings and signage along East Danube Road from West Danube Road to North Innsbruck Drive.

Staff is also collecting and reviewing traffic data upon request for changes to reduce traffic impacts on North Danube Road and Arthur Street.

Construction

The Contractor's hours will be from 7:00 a.m. to 7:00 p.m., Monday-Friday. There is potential for occasional work outside of these hours with City approval.

Please keep in mind that this type of construction may generate noise, dust, mud, and be disruptive to the area. Please be patient with the Contractor and contact us if you have any concerns we can help with.

Resident Access

During construction, the City and contractor will work to minimize inconvenience to residents. That said, residents can anticipate occasional impacts to utility services and driveway access during various phases of construction. Generally, impacts to utility services are limited to short durations (hours) while driveway access may be impacted for up to 7 days during concrete work. Properties impacted by construction activity shall receive advanced written notice of such work.
